ON APRIL 22, 2017, AT 4:31 A.M., A MULTIPLE VEHICLE COLLISION OCCURRED IN THE AREA OF SOUTHBOUND SR-99 AND MAIN STREET IN RIPON. DURING THE COLLISION, ONE PARTY SUSTAINED FATAL INJURIES. ONE OF THE INVOLVED VEHICLES FLED THE SCENE TRAVELING SOUTHBOUND ON SR-99. A LARGE PIECE OF VEHICLE BODY PLASTIC WAS FOUND AT THE SCENE. THE INVESTIGATION REVEALED THAT THE PIECE OF BODY PLASTIC BELONGS TO A 2010 – 2013 DODGE CARAVAN OR GRAND CARAVAN. THE COLOR OF THE VEHICLE IS DARK CHARCOAL. THE BODY PLASTIC PIECE CAME FROM THE FRONT BUMPER ASSEMBLY, SO OUR SUSPECT VEHICLE WOULD HAVE DAMAGE TO ITS RIGHT, FRONT SECTION.
